Agenda Item C: Recommendation voted on by the Road and Bridge Committee

FRAMEWORK:

The Committee believes that on Sept 1st, the Laborers should receive an additional \$1 per hour on top of their existing raise of \$1 that has been previously scheduled. The net effect of that is a \$2 raise on Sept 1st.

Also on the Sept 1st date, those laborers who had been making below the minimum of \$20 per hour will receive an additional \$1 dollar per hour.

New laborers would be \$19 on probation and \$20 per hour after the probationary period ends.

The Committee rejects the idea that all other AFSCME-represented employees of Shelby Co shall also receive a \$1/hour increase to their wages just because of an increase at the Highway Dept. The significant issue facing the Highway Dept of low starting wages for a CDL driver is unique to the Highway Department and does not translate to the other Agencies of the County. It would be unfortunate if the wage framework of the Laborers cannot be improved due to an insistence that other County agencies must also receive an increase or that this effort must be broader instead of narrowly focused.
