Payment Options:

In Person: Real Estate Property taxes may be paid in person at the Shelby County Treasurer's Office located in the Shelby County Courthouse. Cash, check, money order or bank cashier's check are accepted. Office hours are 8:00 a.m.- 4:00 p.m., Monday -Friday excluding holidays.

Payment stubs from the tax bill are required to assure that payments are processed properly.

Local Banks: Most banks in Shelby County can process payments for real estate taxes. A stub is required. The banks will stop accepting payments after the second due date.

Via Mail: Please send check, money order or bank cashier's check along with the payment stub/stubs to:

The postmark date will determine date of pay for 1st and second installments. Mail must be received by the personal check cutoff date and tax sale date. Best practices after the second due date would be to pay in person to assure payment is received and credited to avoid penalties or tax sale.
